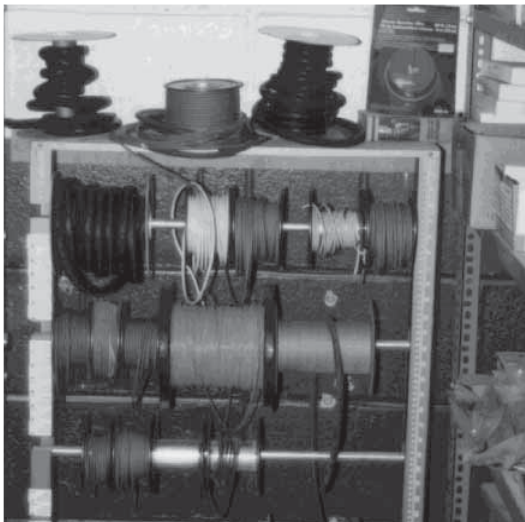

TERMS AND CONDITIONS

1. This Agreement is between the customer and Chromate Industrial Corporation of Solon, Ohio.
2. The purpose is to facilitate the purchase of bin equipment free of charge by the customer.
The amount of \$_____ of bin equipment is being supplied to the customer in exchange for an agreed amount of volume in purchases of Chromate products.
3. Customer agrees to purchase \$_____ of Chromate products over the agreed period

4. Should the customer fail to meet the purchase minimum noted in item 3 above, the customer agrees to pay for the prorated value of the equipment.
